West Point did not accept female applicants, so she joined the Women's Army Corps, where she started her career as one of the first two women trained in aerial surveillance. ## VOCATIONAL REHABILITATION COUNSELOR

My personal journey with Multiple Sclerosis (MS), spanning over two decades, initially brought fear and uncertainty into my life, making me question how it might impact my career, family, and overall well-being. While MS was not welcome or wanted, it has become part of who I am. I've gained a deeper understanding of the emotional and practical challenges that individuals with disabilities encounter.

Being a Vocational Rehabilitation Counselor with MS has reinforced my belief in the importance of resilience, adaptability, and the power of a supportive community. When I interact with clients, I prioritize creating a collaborative and individualized experience that fosters a place for people to have a safe place to discuss their concerns, fears, dreams, and aspirations openly. I strive to foster hope and motivation, emphasizing that a disability does not define one's capabilities or limit their potential.
